**Acute:** Dermal absorption possible. May cause respiratory tract irritation. May cause headache and nausea. May be harmful if swallowed. Ingestion is not an expected route of entry in industrial or commercial uses.

**Chronic:** Prolonged or repeated contact may result in dermatitis. IARC has designated titanium dioxide (TiO<sub>2</sub>) as Group 2B - possibly carcinogenic to humans in dust form. However, a number of long term animal studies and human epidemiology studies evaluating TiO<sub>2</sub> and workplace exposure show insufficient evidence for carcinogenic effects.
